Of course, courts have the authority to protect a plaintiff's due process rights by expanding the boundaries of those rights to protect a plaintiff who has suffered a deprivation at the hands of a state or federal actor. See, e.g., *Loudermill*, 470 U.S. at 536-41, 105 S.Ct. at 1489-91 (recognizing the authority of courts to create due process protections for employees). In other cases, however, there is no authority for expanding a plaintiff's rights or protections in order to protect them. See, e.g., *Kmart*, 746 F.2d at 249 (declining to read due process

protection into otherwise narrow statutory language); *Simmons v. City of Philadelphia*, 947 F.2d 1042, 1064 (3d Cir.1991) (holding that certain procedures under Pennsylvania law for eviction of residential tenants were sufficient even where those procedures did not meet procedural due process requirements), cert. denied, 504 U.S. 986, 112 S.Ct. 2965, 119 L.Ed.2d 586 (1992); *Bright*, 841 F.2d at 588-90 (holding that procedural due process rights of state prison inmates in disciplinary hearings could not be expanded to include a right to unannounced hearings). 13 Citing the Supreme Court's decision in *Board of Regents*, *supra*, *Sughroue* complains that the "independent
